SPECIFICATIONS:

The Giles County Public School System (GCPS) is soliciting proposals for refinishing and repair of gymnasium and stage floor(s) at their schools. All work is expected to be completed during the availability time frames as listed in Transmittal Sheet # 2. GCPS is asking for separate pricing according to the solicited jobs as listed in Transmittal Sheet #2.

All responders must have met the minimum of all identified requirements. If you are interested in touring the gymnasiums and or stage, please contact Dr. Michael Brown or Rachel Carnes (540-921-1421 extension 16 or mbrown@gilesk12.net) and he will schedule a walk-through for you.

The selection process will be in compliance with the regulations under the provisions of the Virginia Procurement Act and Giles County School Board Policy. It is understood that GCPS reserves the right to cancel any contract resulting from this solicitation immediately upon providing notification to the contractor in writing from GCPS. This cancellation will be without liability or penalty to GCPS for breach of contract. GCPS does not discriminate against faith-based organizations.

If this RFP pertains to any school building that is being financed under Virginia Public School Authority, the administrator delegated to review this RFP for the Giles County School Board will take appropriate steps to ensure that IRS regulations regarding tax exempt bonds are not violated in the proposed contract for services.

TERMINATION FOR NONAPPROPRIATION:

Notwithstanding any contrary provisions in this Agreement, the School Board may, at its option, terminate this Agreement as of the end of its fiscal year if funds are not appropriated which, in the opinion of the School Board, are sufficient to meet its obligations hereunder. If sufficient funds are not appropriated, the School Board shall give the Contractor written notice of termination within ten (10) days after the adoption of the final budget for such fiscal year.

SUBMISSION REQUIREMENTS:

A complete response consists of the following:

- 1. Mailed or otherwise delivered in a sealed envelope which indicates the return address of the sender, RFP number, title, receiving date, and time on the outside of the envelope.
- 2. The transmittal sheet(s) enclosed with this document properly completed.
- Certificate of insurance, if applicable.
- Substitute W-9 form (attached).
- Any additional information as may be required by GCPS.

AWARD CRITERIA FOR NON-PROFESSIONAL SERVICES: (if applicable)

Selection shall be made of two or more offerors deemed to be fully qualified and best suited among those submitting proposals, on the basis of the factors involved in the RFP, including price if so stated in the RFP. Negotiations shall then be conducted with each of the offerors so selected. Price shall be considered, but need not be the sole determining factor. After

negotiations have been conducted with each offeror so selected, the public body shall select the offeror which, in its opinion, has made the best proposal, and shall award the contract to that offeror. When the terms and conditions of multiple awards are so provided in the RFP, awards may be made to more than one offeror. Should the public body determine in writing and in its sole discretion that only one offeror is fully qualified, or that one offeror is clearly more highly qualified than the others under consideration, a contract may be negotiated and awarded to that offeror.

NON-DISCRIMINATION:

Per Virginia Code § 2.2-4311 (if contract exceeds \$10,000):

- 1. During the performance of this contract, the contractor agrees as follows:
- a. The contractor will not discriminate against any employee or applicant for employment because of race, religion, color, sex, national origin, age, disability, or other basis prohibited by state law relating to discrimination in employment, except where there is a bona fide occupational qualification reasonably necessary to the normal operation of the contractor. - 2. The contractor will include the provisions of the foregoing paragraphs a, b and c in every subcontract or purchase order of over \$10,000, so that the provisions will be binding upon each subcontractor or contractor.

 Apply as per manufactures instructions. Contractor will touch up any game line paint, graphics, or markings if necessary. Touched up areas will match paint color.

- Repair / replace water damaged gym floor section, and subfloor, match existing floor stain color, repaint lines in damaged area, and any other work necessary to deliver a complete job. Approximately 650 +/- s.f. or repair / replacement (contractor will need to verify actual s.f. of area to be repaired). Match existing wood floor type and subfloor with new material. Contractor will coordinate area to be repaired / replaced with owner prior to the start of work. Contractor will make sure that area to be repaired / replaced moisture percentage in slab / surrounding area is at a level of industry standards that will permit work to be done and to prevent warpage or defects. Contractor will remove damaged materials and dispose of offsite.
- Apply stain, match existing floor stain color to repaired areas of floor. Apply 2 coats of 50 % high-solids VOC-450 oil-modified polyurethane finish to repaired area of the gym floor. Screen, vacuum, and tack between coats. Apply graphics / lines to match existing. Contractor shall mark game lines and graphics layout to match existing with the use of a precision taping machine for circles and arches. Masking tape should be pulled as soon as the paint starts to set and not allow to stand overnight. Paint should be allowed to dry at least 12 hours.
- After lines and graphics have dried to industry standards in repaired area apply 1 additional coat
 of 50 % high-solids VOC-450 oil-modified polyurethane finish on the repaired area. Once the
 repaired area has dried sufficiently apply 1 coat of 50 % high-solids VOC-450 oil-modified
 polyurethane finish with the grain on the entire gym floor with the grain on the entire gym floor.
 Abrade and tack floor between each coat.
- Replace interior door thresholds to match existing removed thresholds.
- Contractor will vacuum, clean, and tack the floor prior to moving on to the next step(s) as per industry standards.
- Contractor will make sure that gym is cleaned, free of sanding dust, contractor work
 equipment, trash (etc.) and ready for use after job is completed.

- Prior to starting any work on existing gym floor contractor shall generate a gym line(s) and graphic(s) layout drawing. Contractor shall submit line and graphic line layout drawing to the owner for approval. Stain and paint colors for the floor and all lines / graphics shall be included in the stain / color graphic drawing submission. Once gym line and graphics drawing has been approved, then contractor shall provide a stain and paint sample of actual approved colors applied on a sample wood board that matches the type and species of existing gym floor. Sample will need to be approved by owner prior to staining and painting of line on gym floor.
- Contractor shall inspect and verify with owner any areas of existing gym subfloor / floor that may need to be repaired or replaced. Any area of the gym subfloor / floor that needs to be repaired or replaced shall match existing gym subfloor / floor materials. Contractor will need to include any repair in the price of the bid.
- Contractor shall remove any and all tape / foreign material on existing gym floor prior to sanding the floor in such a manner that no tape / residue is left on existing floor prior to sanding.
- Contractor shall sand existing gym floor to bare wood. All painted graphics / lines shall be removed. Existing gym floor shall be sanded to industry standards that will ensure a surface ready to be smooth, stain, sealed, and graphics ready.
- Contractor shall apply stain as per manufactures directions.
- Contractor shall seal / apply 2 coats of 50 % high-solids VOC-450 oil-modified polyurethane finish. After first coat is fully dry contractor shall abrade the surface as per industry standards to make it ready to receive a second coat of sealer. Apply as per manufactures instructions to prepare surface for court layout.
- Contractor shall mark approved game lines and graphics layout with the use of a precision taping
 machine for circles and arches. Masking tape should be pulled as soon as the paint starts to set
 and not allow to stand overnight. Paint should be allowed to dry at least 12 hours.
- After lines and graphics have dried to industry standards, abrade and tack floor. Apply 2 even coats of 50 % high-solids VOC-450 oil-modified polyurethane finish with the grain. Abrade, vacuum, and tack between coats.
- Note for above work: Contractor will vacuum, clean, and tack the floor prior to moving on to the next step(s) as per industry standards.
- Contractor will make sure that all of the gym is cleaned, free of sanding dust, contractor work equipment, trash (etc.) and ready for use after job is completed.

- Prior to starting work contractor will cover and secure any electronic and / or sensitive stage
 equipment that cannot be moved, and auditorium seating (if applicable) that will prevent dust
 or damage due to refinishing. Contractor shall make sure that existing curtains are protected in
 such a manner that they will not be subject to sanding dust.
- Contractor shall provide a paint and sealer / finish sample to owner for approval prior to starting work.
- Contractor shall inspect and verify with owner any areas of existing stage subfloor / floor that
 may need to be repaired or replaced. Any area of the stage subfloor / floor that needs to be
 repaired or replaced shall match existing stage subfloor / floor materials. Contractor will need to
 include any repair in the price of the bid.
- Contractor shall remove any and all tape, paint, and foreign material on existing stage floor prior to screening the floor in such a manner that no tape / residue is left on existing floor prior to sanding.
- Contractor shall fill / repair any gouges in floor to a smooth paint and sealer ready state.
 Contractor shall screen existing stage floor prior to paint application. Existing stage floor shall be screened to industry standards that will ensure a surface ready to be paint and sealer ready.
- Contractor shall apply 1 coat of Rust-Oleum oil based flat black paint (or equal) as per manufactures directions Thin only if necessary to ensure a smooth finish.
- Contractor shall seal / apply 1 coat of satin finish 45 % high-solids VOC-450 oil-modified polyurethane finish.
- Note for above work: Contractor will vacuum, clean, and tack the floor prior to moving on to the next step(s) as per industry standards.
- Contractor will make sure that all of the stage is cleaned (including floor receptacles and floor gang boxes), free of sanding dust, contractor work equipment, trash (etc.) and ready for use after job is completed.
