SPECIFICATIONS:

The Giles County Public School System (GCPS) is soliciting proposals for maintenance of elevators and lifts as listed on Transmittal Sheet #2:

The resulting contract will be placed with the chosen vendor for a period of three years (May 1, 2024 to April 30, 2027) and will not be re-advertised on an annual basis unless deemed necessary by the Giles County School Board. All responders must have met the minimum of all identified requirements. At the conclusion of the original 3 year contract, GCPS reserves the right to extend the contract for up to 3 additional one-year terms with a possible agreed upon increase in compensation not to exceed the increase in the consumer price index.

All responders must have met the minimum of all identified requirements. If you are interested in touring the locations as noted on Transmittal Sheet #2, please contact Dr. Michael Brown (540-921-1421 extension 16 or mbrown@gilesk12.net) and he will schedule a walk-through for you.

The selection process will be in compliance with the regulations under the provisions of the Virginia Procurement Act and Giles County School Board Policy. It is understood that GCPS reserves the right to cancel any contract resulting from this solicitation immediately upon providing notification to the contractor in writing from GCPS. This cancellation will be without liability or penalty to GCPS for breach of contract. GCPS does not discriminate against faith-based organizations.

If this RFP pertains to any school building that is being financed under Virginia Public School Authority, the administrator delegated to review this RFP for the Giles County School Board will take appropriate steps to ensure that IRS regulations regarding tax exempt bonds are not violated in the proposed contract for services.

TERMINATION FOR NONAPPROPRIATION:

Notwithstanding any contrary provisions in this Agreement, the School Board may, at its option, terminate this Agreement as of the end of its fiscal year if funds are not appropriated which, in the opinion of the School Board, are sufficient to meet its obligations hereunder. If sufficient funds are not appropriated, the School Board shall give the Vendor written notice of termination within ten (10) days after the adoption of the final budget for such fiscal year.

AWARD CRITERIA FOR NON-PROFESSIONAL SERVICES: (if applicable)

Selection shall be made of two or more offerors deemed to be fully qualified and best suited among those submitting proposals, on the basis of the factors involved in the RFP, including

price if so stated in the RFP. Negotiations shall then be conducted with each of the offerors so selected. Price shall be considered, but need not be the sole determining factor. After negotiations have been conducted with each offeror so selected, the public body shall select the offeror which, in its opinion, has made the best proposal, and shall award the contract to that offeror. When the terms and conditions of multiple awards are so provided in the RFP, awards may be made to more than one offeror. Should the public body determine in writing and in its sole discretion that only one offeror is fully qualified, or that one offeror is clearly more highly qualified than the others under consideration, a contract may be negotiated and awarded to that offeror.

NON-DISCRIMINATION:

Per Virginia Code § 2.2-4311 (if contract exceeds \$10,000):

- 1. During the performance of this contract, the contractor agrees as follows:
